I. Call to Order

Vice President Jermaine Jackson called the November 30, 2023, regular Board of Education meeting to order at 7:01p.m. in the Boardroom of the Administration Building, 1220 Howard Street.

II. Pledge of Allegiance

The Pledge of Allegiance was recited.

III. Acceptance of Agenda

IV. Attendance

Trustee Sholler-Barber reported that the Academic excellence committee spoke about the strategic plan Dr. Slade is working on and discussed a community wide reading event.

Trustee Jackson reported upcoming events the Community Engagement committee is developing.

Trustee Sholler-Barber reported that Communities in Schools met the previous Friday to discuss their strategic planning. Also, she stated how excited they were for the ugly sweater party that is happening on December 5. She made a pitch for CIS as well by explaining who they are and what they do for our students.

Trustee Alcala stated that the Operations committee met on Tuesday that week. Dr. Slade went over monthly financials with the committee. Facilities Executive Supervisor Karen Jackson went over the bond timelines for upcoming years and provided overviews of various items such as payment distributions. Mrs. Terri Aman provided an update about purchase recommendations needed for transportation. Dr. Slade also mentioned different employment opportunities through KPS.

Purchase recommendations were as follows:

- 2024-12 in the amount of \$37,500.00 from Transportation to replace the 1987 tow truck.
- 2024-14 in the amount of \$71,164.00 from Transportation to replace the 2002 and 2003 maintenance vans.
- 2024-13 in the amount of \$2,984,521.00 from Transportation to replace buses that have passed their useful life in miles and years.
- 2024-15 in the amount of \$404,354.00 from MDE Section 97 Safety Grant to add additional security cameras at eight elementary schools.
- 2024-16 in the amount of \$3,983,183.00 from 2018 and 2022 Bonds to replace the stone panels at Kalamazoo Central High School.

Board discussion:

Trustee Sholler-Barber was very pleased that the purchase recommendations were all based around security and safety.

Vice President Jackson asked for a better understanding of the panels being replaced at Kalamazoo Central. Ms. Jackson further explained their purpose along with a timeline.

President Harrison was thankful for getting to see the bids, understand what they were for and having a good explaination of the project.

IX. Reports and Recommendations

A. Presentation from Mrs. Robin Greymountain:

Supporting Students that are Homeless and in Foster Care - Robin Greymountain is the Homeless Liaison, Kalamazoo County McKinney Vento Coordinator, Foster Care Liaison, and Adult Education Leader. What is Homelessness? - Lacking a fixed, regular, and adequate nighttime residence. Homeless living situations include sharing the housing of others due to loss of housing, economic hardship, or a similar reason (doubled-up). Living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations is another homeless living situation as well as staying in emergency or transitional shelters and sleeping in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.

Indicators of Homelessness - Percentage of students who report feeling uncomfortable disclosing their homelessness and seeking help at school. Student homelessness doesn't always look like we'd expect. Instead, we may notice struggles or behaviors that reflect the trauma of losing housing, sleeping on someone's couch, staying in a shelter, or sleeping in a car.

Potential Indicators of Homelessness - Tardiness or absences, poor hygiene, wearing the same clothes repeatedly or not appropriately dressed for the weather, unmet medical/dental needs, missing the bus, sleeping in class, fatigue, hunger, enrollment at multiple schools, lack of records, gaps in learning, social and behavioral challenges like extreme shyness, anxiety late in the school day, lack of participation in field trips or after school activities, lack of school supplies.

Homelessness is a traumatic experience for children and youth. The devastating impact of homelessness begins early in life, with harm to health and development prenatally, in infancy, in early childhood, and in school-age years. Students experiencing homelessness are more likely to drop out of high school and have high school rates that are well below graduation rates who are poor but have stable homes. Tragically, not getting a high school degree or GED is the single greatest risk factor for experiencing homelessness as a young adult. Youth experiencing homelessness who do persist to graduate from high school face significant barriers to achieving higher education, which is the surest path to economic independence.

The Importance of Identification - Homelessness creates significant educational barriers for children and youth. Students experiencing homelessness lack basic resources like a safe and stable place to live, food and clothing, all of which impacts their ability to attend and succeed in school. They also may lack school and immunization records, other documentation necessary to enroll in school, and school supplies. Additionally, students in homeless situations may not only lack the ability to provide their own transportation to school daily, but also may struggle with getting to school to register or enroll.

Educational Rights of students experiencing homelessness - While the McKinney-Vento Act provides children and youth experiencing homelessness with certain educational rights, families or unaccompanied youth may not be aware of the supports available under the Act. They will receive immediate school enrollment, even if lacking paperwork normally required, or their right to continue attending the school of origin, if this is in their best interest, even if they have moved outside the school's residential zone. Free school meals and transportation to students experiencing homelessness as well as resources to remove barriers.

Statistics - 1.3 million children and youth experience homelessness in the 2019-2020 school year. This was an all-time record and roughly equal to the population of Dallas, Texas. Another 1.4

million under the age of 6 are estimated to experience homelessness. In addition to children who experience homelessness with their parents, at least one in thirty adolescents ages 13-17, and nearly 1 in 10 young adults 18-24 are estimated to experience homelessness on their own. These numbers are now likely much higher because of the pandemic and related economic and family stress.

Unaccompanied Homeless Youth - Unaccompanied homeless youth are young people experiencing homelessness who are not in the physical custody of a parent or guardian. Homelessness among unaccompanied youth is most caused by severe family dysfunction and exacerbated by poverty. Family dysfunction includes abuse, conflict, and substance abuse.

Unaccompanied Homeless Youth Risk - Unaccompanied youth are at a much higher risk for labor and sex trafficking, assaults, and other forms of victimization than their housed peers. Most unaccompanied youth are unable to access safe housing or shelter, for a combination of reasons, including being too young to consent for services without a parent; fear of child welfare involvement; and the lack of services overall: more than half of those who seek shelter cannot access it because shelters are full.

Building Homeless Point of Contacts - Every school is required to have a Building Homeless Point of Contact. Building Point of Contacts help to support and remove barriers for students experiencing homelessness.

Identification - School secretaries, teacher, staff, volunteers can refer families that are suspected as being homeless to Mrs. Greymountains office. Mrs. Greymountain can contact families and complete an intake form to determine eligibility. Not every family referred is homeless, but many unidentified families are struggling and need to be referred. Also, remember that it's a delicate and sensitive process.

Vice President Jackson thanked Mrs. Greymountain for her presentation and helping people understand the situations that others go through.

Trustee Sholler-Barber stated that the presentation was so respectful, and that Mrs. Greymountain did an amazing job having the correct supports up around the issues.

Trustee Alcala thanked Mrs. Greymountain for her presentation. She also asked if our fund that we have for homeless students must go to the "book" definition of homelessness. Mrs. Greymountain explained where the funds need to legally go. Trustee Alcala then asked how the board could help support the matter more. Mrs. Greymountain said its helpful having people know and become aware of the situation.

Trustee Murphy asked what percent of Kalamazoo students were homeless. Mrs. Greymountain gave her the statistics explaining approximately how many students were homeless in KPS.

President Harrison asked what the support looks like during breaks. Mrs. Greymountain stated that there is a whole procedure done during breaks so that they are not left homeless alone.

Trustee Johnson stated her appreciation for the work Mrs. Greymountain is doing and how shocking it was to hear the number of students that are homeless.

Trustee Murphy explained that she has people come and stay at her house so they aren't on the streets.

President Harrison thanked Mrs. Greymountain for her role at KPS. She reminded everyone that there is a gingerbread house competition for $3^{rd} - 9^{th}$ graders, 14 and under.

Dr. Slade recognized all the students who are excelling at their sports.
