POLICY of the BOARD OF EDUCATION KALAMAZOO PUBLIC SCHOOLS

1.2 Public Participation During a Meeting of the Board of Trustees

Policy

While balancing legitimate privacy interests of students and staff, the Board of Trustees welcomes community input at public meetings of the Board of Trustees.

Specifics

- 1. Persons requesting to address the board will be asked to complete a sign-in sheet by the end of the public comment period. The portion of that sign-in sheet requiring completion will include: name, school district in which the person resides, and connection to/interest in the Kalamazoo Public Schools. The optional portion will be held private and will include: mailing address, email address, phone number, topic about which they will be speaking and, if authorized and applicable, the organization they represent.
- The presiding board officer will invite persons to come to the podium in the order in which the signin sheets were completed.
- 3. If after 30 minutes everyone who has completed a sign-in sheet has not had the opportunity to address the board, the public comment period will be tabled and resume before adjournment.
- 4. Speakers have three minutes each and must stop speaking promptly when signaled.
- Speakers may not address confidential student or personnel matters, but may submit such concerns to the board in writing.
- Speakers are encouraged to provide the board with a written copy of their comments and other appropriate supporting documentation, which will be copied and distributed as needed to appropriate staff/personnel.
- 7. The public is required to exercise common courtesy during the meeting and must follow rule of order. The presiding board officer may terminate public comments that are profane, vulgar, or defamatory, especially if these comments result in a disturbance or breach of peace. Personal attacks against an employee or board member that are totally unrelated to his or her duties are prohibited. If a person engages in disruptive conduct or is out of order, the board presiding officer will strike his or her gavel and warn the person to discontinue their behavior. Further disruptions will result in the person being asked to leave. Refusal to leave will result in being escorted out of the building. (MCL 380.1808)

MOTION: Trustee Maddock, supported by Trustee Hill, made a motion to accept the agenda as presented.

Disposition: Voice vote; all in favor. Motion carried unanimously.

IX. Reports and Recommendations

A. Interim Superintendent's Update

Thank you, President Harrison, Board of Education Trustees and community. I appreciate the opportunity to share what has been accomplished for the 2022-2023 school year and report on academic achievement. In collaboration with others, we have accomplished a lot. I would like to thank the executive cabinet team of Ms. Sheila Dorsey-Smith, Dr. Amy Vondra, Mrs. Laura Kayser, Ms. Rikki Saunders, Mrs. Caycee Sledge, and Mrs. Susan Coney. In addition, there are many others including directors Mr. Matt Johnson, Mr. Geoff Howe, Dr. Micole Dyson, and Mr. Craig McCane worked intensely on the academic side of the district. Ms. Karen Jackson, Mrs. Terri Aman, Mr. Don Webster, Mr. Rhoan Ruddock, Mr. Steve Leland, Mr. Ian Haight, and union presidents Mark Hill, Heather Reid, and Joanna Miller. It takes all of them plus many more to educate our students. It has been an honor to serve with them.

Areas of Focus - Three Cs

As we conclude this school year, I will be summarizing what has been done. We started by focusing on three major areas called the three Cs. By creating a focus, staff were able to refer to where the concentration needed to be.

The first area is climate/culture for academic success and social emotional learning. The central office administrative team collaborated with building principals in the Instructional Leadership Team meetings. I greatly appreciate the executive cabinet members who worked hard to connect academics as the primary focus. Information was shared to concentrate on literacy and numeracy.

The high school courses now have more diverse authors and literature. This is extremely helpful so our students can dream and set goals to accomplish what they would like to do. Instructional Rounds were conducted in all buildings so teams of educators can collaborate in improving student achievement.

A number of summer school opportunities have increased so we can meet students where they are in building a better future. We updated Policy 4.5 Testing Out of Courses to help meet current standards. We continued the work called "Problem of Practice" and social emotional learning supports. The SEL work is nationally recognized.

Areas of Focus - Three Cs Career Pathways

This year, Dr. Tracy Miller has been instrumental in working with career pathways. She has written and received grants, worked intensively with local business partners, and collaborated with other support agencies.

KPS received a \$101,000 grant in March 2023 for expansion and development of Career Launch Kalamazoo (CLK) based on Strategic Plan for Youth Apprenticeships (YAs) in collaboration with national partners and alliances on youth apprenticeships.

In partnership with KVCC, Developing YA Pathway for Cybersecurity at KVCC.

Increasing employer and partner training and support on YAs with The Kalamazoo Promise in critical occupation areas.

Exploring Career Exploration Virtual Reality Technology in apprenticeable career pathways - High Schools - Beginning Fall 2023.

In partnership with The Kalamazoo Promise and KVCC, growing CLK Employer Partnerships: Business and Industry Information Session and Tour of KVCC's Advanced Technology Center, July 25, 2023. Lunch and Discussion (More info to come)

CLK Aspiring Apprentice Academy, July 19 and 20, 2023, at KVCC for accepted students. (More info to come)

This school year, in partnership with The Kalamazoo Promise, all Secondary KPS counselors participated in a six-day Chicago College Career Advising training (and received their credential [all but one]) in examining and addressing equity issues in coaching and postsecondary planning, practiced youth-centered coaching strategies such as goal setting and cultural responsiveness, learned about postsecondary pathways, gained insight and understanding of labor market, and developed tools to help

youth explore their passions that also included sessions on the importance of YAs.

Areas of Focus - Three Cs Communication

December, there has been an intentional plan to make regular visits to the schools. This has been very well received. The board of education has received weekly updates as well as emergency communications. I have attended numerous school and community events creating a sense of inclusiveness and visibility. We worked together to create a Contact Guide for better communication at the district level. I assisted Western Michigan University with the search for the new dean in the College of Education and Human Development. We had a number of special board workshops to develop a cohesive team.

In addition, I sought input from the Instructional Leadership team which is comprised of building level principals and assistant principals as well as central office administrators.

Feedback from Instructional Leadership Team:

- Need to increase monitoring and accountability measures
- Practice implementing higher order thinking questions
- Encouraging teachers to work in teams
- Conducting regular data meetings
- Provide equity training to reach all students
- Help staff develop positive, supportive relationships with students

Benchmark Goals

P.A. 48 Section 104a requires districts to implement benchmark assessments to measure student proficiency in reading and mathematics. School districts are required to administer these benchmark assessments within the first nine weeks of the year and again prior to the last day of the school year. Data from the assessments may not be used for accountability purposes, rather they are intended to measure meaningful progress toward mastery of grade-level content standards. School districts are required to report on attainment of proficiency and/or growth goals in both February and June.

High School Goal: Students 13/15 Courses by School

Data suggests that at LN and KC students are doing slightly better in 22-23 than they were in 21-22 and far better than they were in 20-21. Phoenix numbers are adjusted to show the percentage of students who successfully complete classes in 85% of their opportunities to do so over the course of the school year.

High School Goal: Student Grades of C+ or Better by School Issuance of grades of C+ or better is relatively the same across KC, LN, and Phoenix

High School Goal: Students 13/15 Grade

The percentage of students meeting the goal has steadily increased over three years for 9th graders. 10th and 11th grade numbers have stabilized. Seniors have a significant drop in the percentage of students who don't meet the goal, but as you'll see in the next slide they are the group that is most likely to earn grades of C+ or better by a significant margin.

High School Students Grades of C+ or Better by Grade

As students progress through the HS grade levels they tend to earn higher grades.

High School Students 13/15 by Ethnicity

The two groups least likely to meet the goal (Black/AA, paid and Black/AA, Free/Reduced) have shown steady gains over the past three years.

High School Students C+ or Better by Ethnicity

Each racial subgroup (Black/AA, Hispanic, White) is far more likely to earn grades of C+ or better if their family income is higher (14-24 points higher). The achievement gap between poor black students and middle/high income white students is alarmingly high.

K-3 Goal 1: At or Above Grade Level in Reading

All grades have significantly more students who score at or above grade level than they did at the start of the school year. As you look at K-3 data you'll notice that a higher percentage of students are identified as on grade level with each grade.

4-8 Goal 1: At or Above Grade Level in Reading

The percentage of students who score at grade level stabilizes through the 4-8 grade bandwidth the exception of 6th grade, which can be a challenging transition year.

K-8 Goal 1: At or Above Reading % Point change in scores (ethnicity & F/R)

Overall, and across all subgroups, a greater percentage of students score at or above grade level in the spring than in the fall.

K-3 Goal 1: At or Above Grade Level in Mathematics

All grades have more students who score at or above grade level than they did at the start of the school year. Growth is highest in grades K-1.

4-8 Goal 1: At or Above Grade Level in Mathematics

The percentage of students who score at grade level is relatively stable through the 4-8 grade bandwidth, with a slight dip in 5th grade.

K-8 Goal 1: At or Above Mathematics % Point change in scores (ethnicity & F/R)

Overall, and across all subgroups, a greater percentage of students score at or above grade level in the spring than in the fall. Black/AA and Free/Reduced subgroups have the highest rate of growth in Math.

K-3 Goal 2: Students Making 1+ years of Growth in Reading

In grades K-2, more than half of our students make 1+ year of growth in a single year.

4-8 Goal 2: Students Making 1+ years of Growth in Reading

In grades 4-8, the percentage of students who make 1+ year of growth in a single year is relatively stable with a dip in 6th grade and a jump in 7th as they transition further into middle school.

K-8 Goal 2: Students Making 1+ years of Growth in Reading (ethnicity & F/R)

In K-8, 52% of all students make 1+ years growth in reading. Students with IEPs (as a stand-alone group) are the least likely to experience normal or high rate of growth in reading, and students on paid lunch (as a stand-alone group) are most likely to experience normal or high growth in reading.

K-3 Goal 2: Students Making 1+ years of Growth in Mathematics

In grades K-1, more than half of our students make 1+ year of growth in a single year.

4-8 Goal 2: Students Making 1+ years of Growth in Mathematics

In grades 4-8, the percentage of students who make 1+ year of growth in a single year is relatively stable with a jump in 5th, 7th, and 8th grades.

K-8 Goal 2: Students Making 1+ years of Growth in Mathematics (ethnicity & F/R)

In K-8, 50% of all students make 1+ years growth in reading. Hispanic students are the least likely to experience normal or high rate of growth in math, and students with two or more races, white, and paid lunch (as stand-alone groups) are most likely to experience normal or high growth in math.

Goal Update

In prior years, the district has used some other means to increase student achievement. We are not able to report on the state M-Step scores until late summer. I would like to share where we are with two focus points.

Grade 8 Algebra

We know that the more students in advanced courses or with a more rigorous curriculum, the better students do. It is important that we have high expectations for all students.

Advanced Placement Courses

High school students taking advanced placement courses are better prepared for post secondary options.

Equity Task Force

For the last two years, KPS has partnered with the National Equity Task Force to work on equity in the district. This was a team of staff, parents, and community selected to participate in 2021.

The group focused on two areas. One was academic rigor and the second area was social emotional learning/mental health of students.

High school students were asked to gather input on how things are going. Students overwhelmingly spoke of the importance of the relationship with their teachers. This is considered to be essential for learning and social wellbeing. Students appreciate a caring and "knowing me as a person" teacher. Students added that extracurricular activities help and they would appreciate more help in being better prepared to take the ACT/SAT testing.

A survey was conducted by the task force for teachers. Teachers identified barriers that prevent students from having access to rigor. They cited student attendance and behavior, lack of encouraging students to

take advanced classes, large class sizes, lack of staffing, and lower teacher expectations for students of color.

Task Force members interviewed parents for input at one high school. Parents would like a greater connection with the school. They would like to hear more from teachers. Safety is one of the concerns. Task force members would like to see more parents interviewed.

The overall results from the task force focused on a proposal of short term next steps to include:

- Focus on relationship building (staff-student)
- Explore how more students can connect to extracurricular activities
- Explore curricular changes to help students with higher level thinking skills and better prepared for the next step
- Explore why some students do not feel safe or do not feel like they belong at school

Summer School

Kalamazoo Public Schools Summer programming will include a variety of opportunities for kindergarten through high school students. At the high school level students will participate in two, eleven day credit recovery sessions where they will be able to earn credits in core science, math, ELA and Social Studies courses. High school students will also have an opportunity to use an online program for credit recovery purposes. At the middle school level we will have programming for current 5th graders (rising sixth graders) and two programs for current 8th graders (rising ninth graders) to help prepare them for the transition to a new secondary school. At the elementary level we will have a program for students who will enter into kindergarten for the 2023-2024 school year and two elementary sites for current kindergarten through fourth grade students. All summer programming will meet four days per week, Monday through Thursday. There will be an ESL Newcomers program for students at the elementary, and secondary levels. Special education programming will be available for students that qualify. Students will be recommended by their classroom teachers rising 1-5th grade according to an established criteria. Students will be enrolled in the program based on an assessment of greatest need. Students in rising 9th grade will be automatically enrolled in lieu of retention. The program will run in partnership with CIS. CIS will supplement the classroom staffing model to allow for lower student to adult ratios, support our enrichment programming and coordinate services for students as appropriate.

Other Summer Programs

We highly recommend that parents and family members encourage students to read. Reading is critical to success. I want to encourage all students and families to use the public library this summer. They have fabulous reading opportunities and incentives as well as events. The Kalamazoo Symphony Orchestra continues to provide support for our students. There are camp opportunities at Pretty Lake Camp and Y Sherman Lake Camp. Read and Write Kalamazoo has many initiatives this summer. Students may also participate in the KAMSC Summer programs and the Michigan Colleges Alliance.

Enrollment

Welcome to KPS! We know you will love it here and find many opportunities to learn. We continue a focus on enrollment with our marquees and summer school programs.

Summary

During the last six months, a lot has happened. I wish to thank the board of education for your support in leading the district. We brought back students to be recognized under "Excelsior Students". We have received additional funding to focus on literacy and numeracy. Our partnerships with the community have been strengthened; especially the Promise and Communities In School. The finances are stabilized.

Thank you to our Human Resources Department, we expanded our number of substitute teachers to help in this time of a shortage of staff. We continued the equity work of the district.

In many instances, we implemented accountability measures. We focused on enrollment to find our students and grow in numbers.

There are new health services coming to our students. Loy Norrix High School will have a health clinic with the Kalamazoo Health Department. There are added safety measures and mental health services.

The board collaborated to develop an onboarding process for Dr. Darrin Slade. He has been in the district during the month of June. He visited staff and students the last week of school. The district is providing orientation and support in the transition. He is eager to start and will be a huge asset to the district. His official start date is July 1, 2023.

Trustee Hill commented on the excited information they received on the grant. Wanted to thank the UAW, Mark Hill, Sheila Dorsey-Smith, and Mrs. Kayser on the contract negotiations. She gave a shout out to Laura Kayser and her team for their work on the budget. She thanked Cindy Green for her service the past six months and her whole career.

Secretary Maddock appreciated a lot of the data provided. She stated that the district needs to evaluate the needs of students transitioning to sixth and ninth grades. She is looking forward to hearing what Dr.

President Harrison made reference to the track team at Kalamazoo Central High Schools and the accolades presented tonight. She stated that communication was not her strongest strength and has only been President for six months. She apologized to any of the board members who feel frustrated for going through these hurdles with her. She stated that she had asked for grace and it was denied, and publicly asked for grace again.
